The WHO... EEBC TEAM INTERVENING | On Behalf of EEBC Members

1. DSM Expert and Witness | Howard Geller, EEBC Counsel EEBC's lead DSM Expert and Technical Advisor will be Howard Geller with the support of EEBC's Heat Pump/HVAC Action Groups as the field experts, representing their experience and business realities on the front lines. This synergy creates opportunities to validate our arguments with field-generated business data analytics – both qualitative and quantitative. Howard will collaborate with other key EEBC stakeholders intervening like WRA, SWEEP, NRDC/Sierra Club, CEO, EOC, etc.

2. Field Experts Inform Policy Arguments | EEBC Action Groups and Heat Pump Field Witness

"Combined Expertise to Intervene in Xcel Energy Dockets" | Howard Geller develops overarching goal-making for policy arguments with trade member input facilitated by EEBC Staff who all coach the "field testimony witness" from industries such as:

- Heat Pumps/HVAC
- Building Envelope Insulation/Air Sealing
- Commercial Lighting

These Action Groups include, contractors, distributors, and manufacturers that operate their businesses across Colorado. For the DSM Strategic Issues docket, they will provide technical and market input on topics such as appropriate BE targets, policies for training and market development programs, policies related to program evaluation, etc.

"Field Testimony Witness" | EEBC Installer/Contractor

EEBC is exploring an "informal proceeding format" for a contractor witness to speak directly from their experience as an installer and business operator. Guidance and written testimony support will be provided to the field witness by Howard Geller and EEBC staff.

"HP Acceleration Forecast for Colorado's Shareholders Shared Goal HP # by 2030" | EEBC HVAC Distributors/Manufacturers

EEBC analytic partners are collaborating on an "aggressive and realistic" **COLORADO'S SHARED HEAT PUMP ACCELERATION FORECAST. The** intent is to develop field-driven analytics and work in tandem with the stakeholders – Colorado Energy Office, utilities, Cities, Gov't Agencies, etc., who are deciding "the rulemaking" to ensure the industry can hit the State's carbon-free, emission goals by 2030.

3. Legal Advisement and Administrative Filing | Dietze & Davis, EEBC Legal Counsel

Advises EEBC staff and members on how to develop and write their "special initiative" rebate/incentive proposals, negotiates with Xcel Energy on incentive program changes or new rebates with EEBC members. EEBC members remove barriers to rebate implementation in the field through this process!




